
Carl D. Perkins Career and Technical Education Improvement Act of 2006 Public Law 109-270 (Perkins IV)






Carl D. Perkins Career and Technical Education Improvement Act of 2006 Public Law 109-270 (Perkins IV)


- Signed into law on August 12, 2006.
- Authorizes federal funding assistance to secondary and postsecondary career technical education (CTE) programs.




Carl D. Perkins Requirements Section 118 Occupational and Employment Information

- Prepare students for high skill, high wage, or high demand occupations.
- Prepare students for non-traditional fields.
- Provide available occupational information industry sectors, job openings, and occupation supply & demand.







Elements of a High Quality CTE System:

Building a demand-driven CTE system by responding to real workforce development needs and state, regional, and local labor market realities and priorities, through strengthened curricula, professional development, data collection and use, and direct linkages with business and industry.



Building a demand-driven educational system:

- Relevant to both current and future workforce needs.
- Establish public/private partnerships.
- Ensure enrollments are meeting workforce needs.
- Provide sufficient funding to cover the cost of necessary equipment.
- Use reliable labor market data to plan programs.
- Moves at the speed of business to address workforce needs.



For the education systems to effectively meet the workforce demands of California industry, the following strategies are considered critical:

- Track labor market demands to inform teachers & counselors.
- Maintain close ties to understand local workforce needs, detect shifts, and offer coursework.
- Support and align advisory committees at local & regional levels.
- Encourage partnerships among local business, workforce, and educational partners.
- Ensure sufficient funding for program development, equipment, and faculty professional development/externships.




California State Statutes





California State Statutes – Secondary & ROPs

- CA Code of Regulations, Title 5, Section 11504(j) specifies that courses offered by Regional Occupational Centers and Programs (ROCPs) may only be for providing training, upgrading, and retraining in recognized occupations and/or emerging occupations to meet the labor demand.
- CA Education Code, Section 52302.3 requires that every CTE course or program offered by a ROCP be reviewed every two years to ensure that each course or program meets a documented labor demand.
- CA Education Code, Section 52519 requires the governing board of any high school district or unified district, prior to establishing a CTE program for adults, to conduct a job market study of the labor market area in which it proposes to establish the program




California State Statutes – Adult School & Community Colleges


- CA Education Code, Section 52520 requires that every CTE training program for adults offered by any high school district be reviewed every two years to ensure that the program continues to meet a documented labor market demand.
- CA Education Code, Section 78015 requires the governing board of a community college district, prior to establishing a CTE or occupational training program, to conduct a job market study of the labor market area.
- CA Education Code, Section 78016 requires that every CTE or occupational training program offered by a community college district be reviewed every two years to ensure that it continues to meet a labor market demand






Federal Program Monitoring

Current California Labor Market Information










Current Conditions

- The California unemployment rate has fallen faster than the nations over the last two years.
- The private sector had 17 consecutive months of job gains (broken in December 2012).
- Job growth in 2012 was 20th in the nation and California's private sector growth was 11th in the nation.
- 2012 saw a slow down in Nov/Dec. the rest of the nation did not.
- Anything tech related in these CA sectors were hit hard by the slowdown
 - Professional & Business Services
 - Manufacturing
 - Construction




Where are we going?

- The lack of government spending is dragging on the economy.
- Global slow down is hurting California.
- But moderate pace will pick up in late 2013.
- Hopeful Signs heading into 2014
 - Consumers are spending
 - State & local austerity policies might be ending
 - Housing recovery forecasted
 - Global economy will pickup
- Danger Zones
 - Weakening demand for CA exports
 - High Tech losing its luster
 - Fiscal policy uncertain in Washington DC
- Into the Fire
 - Fiscal Cliff / Debt Ceiling comes back
 - Severe austerity measures would hurt the economy




ProjectionsCalifornia 2020








CTE Model Curriculum Standards Update

 - -Anchor Standards






Pathway Changes

- Health Science and Medical Technology (rewritten with new pathways for Patient Care, Public and Community Health, and Mental and Behavioral Health);
- Information and Communication Technologies (ICT) (updated to include new ICT formats in communication and added a Games and Simulation pathway);
- Public Services (rewritten to include new Emergency Response and Legal Practices pathways); and
- Transportation (rewritten to include all new pathways to represent all phases and modes of transportation: Operations, Structural Repair and Refinishing, Systems Diagnostics and Service).
